SPEAKERS

Randy Blach

Randy Blach is CEO of CattleFax, an organization focused on helping member cattle producers make more profitable marketing and management decisions. CattleFax is the cattle and beef industry leader on timely market information, analyses and research. Blach came to CattleFax in 1981 and served as director of market analysis for 15 years and accepted his current role in 2001. During this time, he has been a keynote speaker at hundreds of cattle and beef industry conventions, meetings and seminars. A Colorado native, Blach and his family remain actively involved in cattle ranching with cow/calf, stocker and finished cattle. He was raised on his family's ranch in Yuma, Colo., and graduated from Colorado State University with a degree in animal science. Blach received the Honor Alumni award from its College of Agricultural Sciences in 2004 and the Livestock Leader Award in 2011.

Brain Bledsoe

Brian is the Chief Meteorologist/Climatologist for KKTV News in Colorado Springs. He is also the President and Founder of BrianBledsoeWx which is his private consulting business. He graduated from the University of Northern Colorado in 1997 with a Meteorology Degree. While still in school, he gained valuable experience as a Meteorologist at KGWN-TV in Cheyenne, Wyoming. The last eight years have taken his life and career to KMEG-TV in Sioux City, Iowa, KDLT-TV in Sioux Falls, South Dakota, and then CBS 58 in Milwaukee, Wisconsin. Brian also does extensive work in long range forecasting focused on ag producers and other industries reliant on weather. Brian is a strong advocate for common sense science reporting, rather than claims of man-made climate change.

Dr. David Kohl

Dr. David Kohl energizes agricultural lenders, producers and business persons with his keen insight into the agricultural industry through extensive travel, research, and exposure during his career. He is Professor Emeritus of Agricultural Finance and Small Business Management and Entrepreneurship at Virginia Tech, Blacksburg, VA. Dr. Kohl has traveled over 9 million miles in his professional career and conducted over 6,000 workshops and seminars for a variety of agricultural audiences. Dr. Kohl's personal involvement with agriculture and interaction with key industry players provide a unique perspective into the future trends of the agricultural industry and economy.

Dr. Stephen Koontz

Dr. Stephen Koontz, Professor and Extension Economist, Department of Ag and Resource Economics, Colorado State University specialized in the areas of commercial commodity agricultural markets of significance in Colorado. These industries include cattle and beef, feed grains, wheat, forage and dairy. His research examines market and price analysis tools, forecasting and modeling methods, and linkage of those tools with agribusiness and risk management. In addition, his research also includes long-term scholarly interests in industrial organization, econometric methods, and experimental economics. Recent projects have involved examining the impact of alternative marketing methods used in livestock industries on the performance of cash markets, examining alternative trading and ownership institutions in experimental economic markets, the impact of ethanol demand on corn and other commodity markets, the economic value of sorting fed cattle, and the economics of animal disease control and insurance.

Mark K. Scanlan is senior vice president of agriculture and rural policy for the Independent Community Bankers of America®, where he has worked since 1994. Scanlan monitors all legislative and regulatory issues related to agriculture and issues impacting rural America.
